## Beginning Private Pilots – Learning to Fly

- Be at least 16 years old to solo
- Be at least 17 years old to take FAA practical test
- Be able to read, speak, and write in English
- Pass a physical exam administered by an aviation medical examiner (or basic med)
- Pass a written exam (at least 70%)
- Complete a practical test with FAA examiner
- TSA clearance for foreign nationals

## Legal Minimum Required Instruction

- 40 hours total flight time\*
    - 20 hours of flight instruction
    - 10 hours of solo
    - 3 hours of cross-country
    - 3 hours of night instruction
    - 3 hours of simulated instrument
    - 3 hours of preparation for practical test
- \*National average is significantly higher

## Steps to becoming a Private Pilot

- Pre-solo: Basic airplane handling, going to/from a practice area, basic take-offs and landings, radio communications (approx. 40 hours). Solo phase check required.
- Cross-country: Navigation to/from distant airports, advanced take-offs and landings, handling emergencies (approx. 20 hours). Cross-country phase check required.
- Practical test: Preparation for the FAA practical test (approx. 20 hours). Private pilot phase check recommended.

## Types of Membership

- **Regular Membership:** Allows full flying and club privileges
- **Military Membership:** Allows full flying and club privileges with a 55% discount on monthly dues
- **Family Membership:** Allows full flying and club privileges with no application fee and 55% discount on monthly dues
- **Associate Membership:** No flying privileges, but entitled to front desk scheduling, social activities, and simulators

## Insurance, Deductible Waiver, and Incidental Damage Policy

- **Insurance:** WVFC provides extensive insurance coverage as part of all rentals. We offer \$2M liability insurance with a \$250K per seat limitation. A deductible of \$3500 (not at fault) or \$5000 applies (at fault).
- **Deductible Waiver and Incidental Damage Program:** For \$150 per year, the club will waive the \$3500/\$5000 deductible in the event of a claim as well as provide coverage for incidental damage such as a flat spotted tire, dead battery, or clean-up from a sick passenger.
